



## Tariffs webradios / music streaming 2024<sup>1</sup>

---

### Small webradios – limited streaming

Lump sum of € 687,08 / year

→ Cumulative conditions : -max. 2 channels on offer  
-and max. 25 simultaneous streams

Lump sum of € 412,24 / year

→ Cumulative conditions : -max. 2 channels on offer  
-and max. 25 simultaneous streams  
-and ≤ 180 days of broadcasting of radio programs per year (regardless of the length of these programs)

### Regular webradios – normal streaming

Lump sum of € 1.374,11 / year

→ Cumulative conditions : -max. 2 channels on offer  
-and total turnover excl. VAT ≤ € 25.000<sup>2</sup>  
-and max. 250 simultaneous streams

Lump sum of € 755,77 / year

→ Cumulative conditions : -max. 2 channels on offer  
-and. total turnover excl. VAT ≤ € 25.000  
-and max. 250 simultaneous streams  
-and ≤ 180 days of broadcasting of radio programs per year (regardless of the length of these programs)

### Large webradios – unlimited streaming

→ Conditions:

-min. 3 channels on offer  
-or total turnover excl. VAT ≥ € 25.001  
-or min. 251 simultaneous streams

→ Tariff: The higher amount of:

-12,5 % of the total turnover excl. VAT  
-or € 0,0010 par phonogram stream<sup>3</sup>, taken into account the startup discounts below

<sup>2</sup> The total turnover excluding VAT taken into account is the one achieved through webradio broadcasting. It includes grants, endowments, sponsorship and advertising revenues, partnership agreements, donations, contributions and other similar incomes.

<sup>3</sup> Phonogram stream = one phonogram (song) streamed to one listener.



### Graduated discounts based on the amount of phonogram streams <sup>4</sup>

| 100.000.001    | 500.000.000       | 45,0 %        |

### Minimal quarterly bill

**€ 1.305,41**

- Conditions:
- valid per channel
  - at the start of the webradio: first payment pro-rata left over months of the quarter
  - to be paid at the end of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> quarter:  $\frac{1}{4}$  of the amount of last year's bill, with a minimum of € 1.305,41. The final bill is drafted at the end of the 4<sup>th</sup> quarter. The outstanding amount is not refundable.
